

Genesis Gym Sports Facility, Waiver of Liability Release from Responsibility, Assumption of Risk, and Waiver

Please read this document carefully and completely before signing. Its effect is to release Calvary Chapel of Russell and Genesis Gym Sports Facility from any and all liability resulting from your participation in the below named activities and waives all claims for damages or losses against the Corporation.

In consideration of my participation in activities offered at Calvary Chapel of Russell, Genesis Gym Sports Facility, (Archery Range including all related equipment, whether own and/or provided by Calvary Chapel of Russell, Genesis gym Sport Facility and their members, officers, agents, employees and any other persons or entities acting on their behalf, and the successors and assigns for any and all of the aforementioned persons or entities, (all of such persons and entities are identified below as "Released Parties") Weight Training, Cardiovascular Exercise including all related equipment, exercise programs, athletic practices i.e. Basketball, Volleyball, Softball, Baseball, Soccer, and any other organized leagues.)

I, _____, the undersigned individual (Group), exercising my own free choice to participate voluntarily in the above-named activities, and promising to take due care during such participation, hereby release and discharge, indemnify and hold harmless the Released Parties against all claims, demands, causes of action whatsoever either in law or in equity, relating to injury, disability, death or other harm, to a person or property or both, arising from participation in and/or presence at the above-listed activities.

I acknowledge that I have been informed of major hazards and risks which may include: sprains, strains, dislocations, amputations, cuts, bruises, breaks, impalement, teeth (broken/loosened/knocked out), head injuries, paralysis, death, travel and other risks associated with my participation in the above-named activities: I understand, accept and assume those hazards and risks, waive all claims against the Released Parties. I understand that I am solely responsible for any costs arising out of any bodily injury or property damage sustained through my participation in normal or unusual acts associated with the above-named activities.

I understand by signing this release that I have given up all future liability claims by me against the Release Parties. I also understand that even if this release were not signed, my assertion of such claims would have to be based on legally recognized wrongful acts or omissions of the Released Parties and that they are **in no way insurers of my safety**. In addition, I understand that because Calvary Chapel of Russell, Genesis Gym Sports Facility, and its governing board are a nonprofit corporation, several limitations and exclusions exist with respect to liability to the Released Parties. Therefore, I have determined whether I have adequate separate insurance to cover all harm that I may suffer due to participation in this activity and I have obtained all insurance protection that I want.

I have had sufficient time to review and seek explanation of the provisions contained above, have carefully read them, understand them fully, and agree to be bound by them. After careful deliberation, I voluntarily give my consent and agree to this Release, Assumption of Risk, and Waiver.
